Recognize an outstanding student by nominating one full-time high school senior, enrolled in a high school in a Comcast community, who demonstrates:

A strong commitment to community service Leadership abilities through activities or work experience A grade point average of 2.8 or higher

Plans to attend an accredited nonprofit college, university, or vocational/technical school in the United States.

The Leaders and Achievers Scholarships are one-time awards in the amount of \$1,000 for use towards qualifying college costs and expenses. Scholarship awards are nonrenewable and are not based on financial need.
